2022 has been another turbulent and eventful year, not just for the Euro-Rijn Group, but also for the world around us. Despite disruptions, we remained committed to growing our organisation even in challenging times. We are keen to share with you this year's most important events and developments.

Dealing with disruptions

Geopolitical conflicts and COVID-19 lockdowns tested supply chains around the world. These events, as well as being tragic in itself, led to transportation delays and high prices for certain commodities, which prompted a lot of uncertainty for the logistics business.

Implications like trade finance banks scaling out of commodity finance, sanctions and rising interest hikes from central banks are disrupting commodity trade and make it extremely difficult for traders to attract working capital. After two years of challenges and disruptions in European road transport, we see the first improvements in the capacity of trucks availability. 

Expanding AWL to Rotterdam

For 2023, we have big plans regarding Euro-Rijn Group subsidiary AWL Moerdijk, led by Dimitri van Bekkum. AWL Moerdijk will operate from four different locations, two at Moerdijk and two in Rotterdam. The warehouses are specialised in the central storage of ADR, chemicals, hazardous materials, food, feed and non-food goods.

Euro-Rijn fitness

Transport over water has always been the heart of Euro-Rijn Group. This makes inland navigation and shipping a strong part of our business. Each year Euro-Rijn Global Logistics alone transports around 1.5 million tons of goods all over the inland waterways of Europe. When it comes down to river transportation we are specialised in shipment of so-called dry bulk, including minerals, metals, ores and project shipment over the European inland water network.

The history of Euro-Rijn Global Logistics

In 1992, our current CEO, Albert van Ommen joined Euro-Rijn. He started to manage and expand the business, then located in Germany, and specialise in the storage of ferro alloys. This led to the start of Euro-Rijn International (now named Euro-Rijn Global Logistics).

In 1994, Euro-Rijn engaged in a partnership with Associated Metal Services to further specialise in the storage and processing of ferro alloys. This also gave Euro-Rijn direct access to its own terminal in Moerdijk. The Euro-Rijn headquarters would relocate to Moerdijk completely in 1997.

A little over ten years ago, in 2011, Euro-Rijn would make two major investments to expand transshipment activities, and in 2013, Independent Commodities Logistics (ICL) started to offer our clients LME-certified storage of metals.

In 2021 Euro-Rijn International and Scheepvaartonderneming Euro-Rijn (Shipping Company) merged to the logistics company with the name of Euro-Rijn Global Logistics.


Euro-Rijn Global Logistics

Waterfall Offices

Euro-Rijn Real Estate, together with HM2 Property Developers, has developed "Waterfall Offices", a hypermodern new office building constructed at a prominent location along the A2 motorway at 's-Hertogenbosch. The modern and unique appearance features a transparent bamboo exterior surrounded by a green environment. Waterfall Offices has been delivered to tenant Otherside at Work, a fast-growing company focused on software for happy professionals.

AWL Energy Logistics

Euro-Rijn Real Estate is currently developing a 18.000 m2 distribution centre focused on the storage and handling of goods by AWL. The distribution centre is located at Maasvlakte II, with excellent connections to the European hinterland via high-frequency multimodal connections.

The newly developed distribution centre is BREEAM very good and GPR 8.0 certified. This means the development is part of a sustainable environment that enhances the well-being of the people who work in it, helps protect natural resources and makes it a more attractive property investment.

The new DC, located at Davisstraat 10 Maasvlakte Rotterdam, will be delivered to AWL in May 2023. At this location, AWL Energy Logistics will mainly focus on contract logistics regarding solar panels and lithium batteries.





The DC is intended to be completed before the 2023 summer holidays by contractor Bouwbedrijf Remmers B.V. to client Euro-Rijn Real Estate.

The DC will be leased to Roadjet Logistics. Roadjet is currently located at the Sluisjesdijk in Rotterdam, but has to leave that location due to redevelopment. Roadjet will move into the new DC in Dordrecht after the 2023 summer holidays.

Lars Overbeek of Roadjet: "Roadjet can realise substantial growth in Dordrecht. The DC perfectly alligns with Roadjet's ambitions in terms of warehouse and dispatch space as well as offices. Roadjet has been working with Transnordic at the current location for many years and would like to continue to do so. The Transnordic team will therefore also move to Dordrecht. In total, approximately 55 people will be working at the new location."

Interview with Kirsten-Julie Boekel

What does Euro-Rijn offer to create value for our employees?

Kirsten: Our focus is on trust and safety in the workplace, while also developing our staff. We offer opportunities for personal growth by stimulating our employees to keep training and educating themselves. The Euro-Rijn Group is a family business and its unique culture distinguishes it from other logistics competitors. We try to make new employees feel at home and we let people be themselves, while also working together as a team.

We frequently organise personnel events for our team, including teambuilding exercises. We also utilise an on-site gym to promote physical and mental health.

How do we ensure we find the right fit for our Euro-Rijn culture and values?

Kirsten: We find most of our new employees by combining online advertising and word of mouth. When interviewing new talent we make sure to clearly communicate the values and culture of Euro-Rijn to be transparent about what working here will entail. We are also not scared to hire talent based on potential instead of experience. We regularly invest in educating and training new employees ourselves. So also without specific degrees or certifications, people can grow and develop at Euro-Rijn.

In what way did the challenges of the pandemic and the job market affect our recruitment strategy?

Kirsten: The pandemic definitely made the recruitment process more difficult. We mainly focused on advertising online through various campaigns and videos. We also expanded our HR and recruitment toam.

We offer flexibility in the way our employees want to develop themselves at the Euro-Rijn Group. This means that we retain many of our employees, which greatly helped us during this period.

And yes, we also did online recruitment sessions, but now that things are back no normal, we prefer the face-to-face interviews much more, Kirsten adds.

Carbon Border Adjustment Mechanism

The European Union (EU) has implemented its climate ambition plan, which will play a big part in the world of sustainable logistics. The EU initiative called Carbon Border Adjustment Mechanism (CBAM) will be implemented as from October 2023 and will have a transitional period until 31 December 2025.

The ambition of the EU is to reduce CO2 emissions, but in non-EU countries there are less environmental policies in place. This may lead to the fact that emissions could shift outside of the EU and this will

undermine EU and global climate efforts. That is why the EU introduces a new mechanism for the import of goods outside the EU and puts a fair price on the carbon emissions during the production in non-EU countries

During the first phase, CBAM will focus on goods most at risk of carbon leakage such as:

- Cement
- Iron and Steel
- Aluminium
- Fertilisers
- Electricity

As of January 2026, the following procedures will be implemented:

- EU importers of goods must be covered in the CBAM register, by purchasing CBAM certificates from national authorities. The price of the certificates will be calculated depending on the weekly average auction price of EU ETS allowances, expressed in Euro/tonne of CO2 emitted.
- The EU importer must declare by the 31st of May of each year the quantity of goods and the emissions of the goods imported into the EU in the preceding year. At the same time, the importer has to inform of the number of CBAM certificates that correspond to the amount of greenhouse gas emissions of the products.
- In case importers can prove, with verified information from the non-EU country producers, that a carbon price has already been paid during the production, the corresponding amount can be deducted from their final invoice. For goods produced in the EU, CO2 emission costs are already in place.

At Euro-Rijn, we are investing in acquiring more insight regarding our carbon footprint and which steps to take to reduce our CO2. We recognise the importance of sustainability and encourage cleaner and more sustainable production and transport in the world of logistics.

The Euro-Rijn Group is always looking for opportunities to further grow and develop the group. This year we have added six new companies to the Euro-Rijn Group. At the end of 2022, Euro-Rijn Group completed four acquisitions to strengthen its logistics position: Oorburg Intermodaal, AquaRoad Logistics, Gäde Warehousing and Gäde Trucking. Furthermore, during 2022 we started two new customs service companies: Customs Expertise Rotterdam and CER VAT.







Expanding AWL Moerdijk

As from 1st of May 2021, AWL Moerdijk will operate from four different locations, two at Moerdijk and two in Rotterdam. The warehouses are specialised in the central storage of ADR, chemicals, hazardous materials, food, feed and non-food goods. AWL Moerdijk also coordinates distribution within Europe or export for their customers from their headquarters in

Regarding ADR storage and distribution we work with 40.000 m2 of storage space and four separated PGS15 bunkers, equipped with an EFSR sprinkler system and a CO2 extinguishing installation (alarm class III). The food and merchant goods are stored in a total of 85.000 m2 of warehouse space with 100 docks and 90.000 pallet places. The warehouses offer 24/7 online customer access to WMS.

The AWL operations will be split up as four new entities; AWL Energy Logistics B.V., AWL Retail Logistics B.V., AWL Food & Feed Logistics B.V. and AWL Hazmat Logistics B.V., all coordinated by AWL Holding. By joining Euro-Rijn Group in 2022, AWL Moerdijk can now further expand these business activities.

Combining new digital systems and technologies with RFID (Radio Frequency Identification) chips will create access to better real-time tracking and analytics for logistics customers and partners. This way it is possible to identify and anticipate potential problems, and resolve them faster.

At Euro-Rijn we utilise a technology to monitor and track our shipping containers to provide our delivered safely at their destination. This also means we can respond quickly in case of any issues.

The fifth generation of mobile communication creates significantly higher connection speed and lower latency. This will affect many industries in transportation and logistics. The higher connection speed of 5G enables new application types to be used

and will greatly support the data exchange throughout the supply chain, which will boost productivity in warehouses by quicker identification and sorting of products. It will also increase conditions in transportation with automation of air temperature and humidity through 5G sensors.

In turn, this innovation paves the way for AI and machine learning to become more prevalent in the logistics world. The integration of AI can reduce the need for physical work by humans and increase efficiency and capabilities while reducing the chances of human errors. The higher connection speed of 5G in combination with the right technological tools will increase business analytics and efficiency throughout the supply chain and in turn boost profitability. At Euro-Rijn XL Logistics we have been utilising robots in our warehouses. The robots allow a mobile conveyer belt to be placed inside a container in order to unload it quicker while minimising the physical impact on employees. This is just an early example of the potential of robotics and AI, which will keep growing. Other examples are mobile robots, shelf robots and autonomous drones for inventory.

Electric and autonomous vehicles

The recent supply chain disruptions were also significantly influenced by a shortage of truck drivers. Self-driving trucks will eventually be the solution to overcome this staffing crisis in logistics and transportation in the future. However this will still take many years to implement and cannot be achieved in the short term.

The first step towards this solution is the trend of electric cars (and trucks). Electric vehicles provide a more economical and eco-friendly mode of transportation. Considering the political focus on sustainability and "green logistics" we can expect electric vehicles to play a big part in supply chains in

On the other hand, the fast growth of the electricity demand will impose challenges for the current energy infrastructure in the Netherlands.

Eco-friendly warehouses

Green logistics, reducing carbon footprint and sustainability are trending topics all over the world. This is why eco-friendly warehouses will be important in the near future of logistics businesses. Eco-friendly

warehouses, next to being more sustainable and reducing a company's carbon footprint, could also reduce storage costs and increase profits. 'Green warehousing' trends will include using solar panels, LED-lighting, recycling areas, low-emitting materials and more. Many of which we currently implement at our Euro-Rijn warehouses.

Future outlook of Euro-Rijn

At Euro-Rijn we believe in innovation and are not afraid to take risks to grow our business in new ways, as well as contribute to making logistics more sustainable wherever possible.
