

# **Euro-Rijn adds Danser Group** to its logistics division



By bundling these services and utilising its connections, they can provide complete transport from door to door if necessary.







# Euro-Rijn Real Estate and AWL Energy Logistics contribute to sustainability of Ikazia Hospital Rotterdam

The distribution center Davisstraat located at Rotterdam's Maasvlakte, developed by Euro-Rijn Real Estate, has been equipped with a solar roof in collaboration with Sunrock. The building has been in use by AWL Energy Logistics since June 2023. Approximately 3,868 solar panels are placed on the roof. This had already been taken into account during the development of the building with regard to construction, roof load and fire safety requirements.

Ikazia uses solar energy for more than 30% of the hospital's total electricity consumption. The remaining 70% of the electricity used by Ikazia Hospital comes from wind turbines. The Rotterdam hospital is the first Dutch hospital to make its business operations 100% sustainable with the help of an external solar park. "All hospitals have high energy consumption," says Matthijs de Vroed, Sustainability Officer at Ikazia. "Don't just consider lighting and heating, but especially air treatment systems, pumps and research equipment. They consume energy. Because it is not possible to generate this energy at our own roof, this combination of wind and solar energy, generated at other locations, is the perfect solution to operate on 100% green energy."

#### Collaboration is a key to success

The collaborating parties regarding this agreement are: Ikazia Hospital Rotterdam, Sunrock as project developer of the solar roof projects, Euro-Rijn Real Estate together with AWL Energy Logistics, whose roof is used for energy generation, and Eneco as an intermediary for the supply.





# Distribution center Dynamoweg Moerdijk

Euro-Rijn Real Estate, together with Bouwbedrijf Vrolijk, will develop a logistics distribution center of approximately 12,000 m<sup>2</sup> at Dynamoweg, Moerdijk. Moerdijk suffers from congestion on the electricity grid. That is why, in addition to a small electricity connection, the building will be equipped with its own battery pack and a roof with PV panels. A truck parking lot for 15 trucks will be built next to the building. Construction is scheduled to start before the end of this year and will be completed in the fourth quarter of next year.

Michiel Aandewiel, Commercial Manager Sunrock: "Thanks to the great collaboration, an unique result has been achieved. By adopting solar roofs, it is now possible to make the hospital's operations more sustainable and thus contribute to the Green Deal sustainable healthcare."

#### **Sustainability**

The big advantage of solar parks on company roofs is that they don't come at the expense of green areas. Biodiversity is not affected and the solar panels don't block rainwater, so the soil can still absorb it. Ard de Keijzer, Managing Director Euro-Rijn Real Estate: "Using the roof of our new building at the Rotterdam Maasvlakte for generating solar power perfectly complements the sustainability ambitions of our company."

# Giovanni van Bronckhorst

Giovanni van Bronckhorst is a football manager and former football player for RKC Waalwijk, Feyenoord, Rangers, Arsenal, Barcelona and the Dutch national team, who with his Giovanni van Bronckhorst Foundation helps children create more opportunities through sports and education.

We spoke to Giovanni van Bronckhorst about the Giovanni van Bronckhorst Foundation (GvBF) and S.V. GIO. As proud supporters of this charitable foundation, Euro-Rijn Group is privileged to sit down with Giovanni to explore the foundation's mission, its impact on communities, and its vision for the future. Established with a commitment to making a tangible difference in the lives of vulnerable individuals, the Giovanni van Bronckhorst Foundation stands for giving back to society through sports and education. With strategic initiatives and partnerships, the foundation strives to address pressing social challenges, particularly focusing on youth development, education, and community engagement.

In this interview, Giovanni shares his insights, experiences, and aspirations behind the foundation's mission and its future.

# What was the driving force behind establishing the Giovanni van Bronckhorst Foundation and what did you hope to achieve when you started the initiative?

**Giovanni:** Towards the end of my career, I felt a strong desire to give back to society. So, when I got back from FC Barcelona, I established the foundation in 2007 with the primary objective of supporting the wellbeing of children. Initially, our focus was on providing support and funding to existing projects. However, as time progressed, we decided to initiate our own project: S.V. GIO. This project aimed to integrate sports and education to empower children to take charge of their own futures.

# Can you tell us more about the main goals of the Giovanni van Bronckhorst Foundation and how these goals benefit the community?

**Giovanni:** Our foundation is committed to assisting and guiding children towards a promising future. We aim to provide them with the necessary direction and support to achieve their goals, whether it's pursuing a specific career path or reaching personal milestones. We strongly believe in the power of sports as a tool for life skill development. Just as sports enriched my life with discipline, teamwork, and confidence, we aim to teach these essential values to the children. I am proud to witness the positive impact we've made over the years, building an amazing project that equips children with invaluable skills for life.

# To what extent have your experiences as a football player and coach influenced the philosophy and approach of the Giovanni van Bronckhorst Foundation?

Giovanni: From a very young age, I knew I wanted to be a footballer; it was a clear goal for me since childhood. Understanding what you want and pursuing it came easy to me. Football not only granted me a career but also instilled in me traits such as teamwork. discipline, a structured routine, and exposure to diverse cultures. My aim is to impart these qualities to all the children we support, helping them identify their own aspirations and charting a course to achieve them. We engage in conversations with the children to help them discover their goals, initiating a 20-week process to outline their paths. Additionally, we facilitate exposure to various professions and industries, broadening their horizons and showcasing the possibilities for their futures. So they can also find their goal and work on chasing that goal.



# Can you share a memorable moment or success story from your experience with the Giovanni van Bronckhorst Foundation?

**Giovanni:** One thing that stands out is the overwhelming gratitude we receive from both the children and their parents. It's incredibly rewarding for me and for everyone involved in the foundation who dedicate their time to making a difference. It's incredibly fulfilling to guide a child towards setting and achieving their goals successfully. That's why it's essential for us to measure the impact along the way, to look at the effectiveness of our programs. This not only helps us ensure success but also allows us to witness the positive transformation first-hand. We see children thriving and enjoying themselves as they progress within our programs, which is of course a great experience.

# What does the future of the Giovanni van Bronckhorst Foundation look like? Are there any new initiatives or projects in the works?

**Giovanni:** Our vision for the future involves expanding our reach to Rotterdam North. Currently, we operate in two locations, and we aim to extend our presence into the North area. Additionally, we are considering the implementation of summer schools in various new locations across the Netherlands. Expanding to new locations is vital as it allows us to reach and help more children.



# **Interview with Ton Bostelaar**

Ton Bostelaar is the Manager Special Projects at AWL Moerdijk, we interviewed him to learn more about the storage of hazardous substances and goods (ADR) and the safety and legal regulations that come with it.

# Can you tell us more about the strategic location of the storage facility for hazardous substances and goods (ADR)?

**Ton:** The Port of Moerdijk is the second container port in the Netherlands and the fourth sea port of national importance. As an engine for the economy of Brabant, it provides direct and indirect employment for over 19,000 people working at more than 400 companies. Sustainability, innovation, and most importantly, safety, are highly valued. Among these companies, we find significant players engaged in the production, processing, and storage of environmentally critical products, and AWL Hazmat Logistics is one of them. Utilising all the facilities that the Port of Moerdijk offers. The Port of Moerdijk is growing in all aspects and is connected to Europe via road, water, rail, and pipeline.

# Can you tell us about how the space is organised and optimised for maximum safety and efficiency?

**Ton:** To ensure safe storage of lithium-ion batteries and metals, the existing storage location DC3 (16,620 m<sup>2</sup>) has been fully equipped and adapted. This means that the layout and racks comply with the required standards and no other products are stored in this



location. Escape routes have been critically reviewed and expanded where necessary. Additionally, in-house tools have been designed to be deployed in case of emergencies, such as a special emergency container and advanced equipment. Our employees are trained to work with breathing apparatus, gas detection equipment, thermal imaging cameras, and they undergo training via animated films specifically designed for this purpose.

What legal requirements and regulations regarding the environment, fire safety, and working conditions

# influence the operation of the storage facility? How does AWL ensure compliance with all requirements?

**Ton:** AWL Hazmat Logistics complies with the new Environmental Act, which came into effect on 1 January 2024, requiring companies to pay extra attention to external safety aspects in their operations due to the presence of licensed quantities of hazardous substances. The new Environmental Act also replaces the Major Accidents Decree (BRZO), with BRZO companies now referred to as 'Seveso establishments'. It is noteworthy that AWL Hazmat Logistics was the first in the Netherlands to be granted a permit for the large-scale storage of lithium-ion batteries and metals. To achieve this, AWL Hazmat Logistics, in collaboration with specialists and authorities, has developed specific measures, procedures, training, and tools to minimise the risk of accidents to the utmost extent.

What initiatives does AWL take to proactively comply with changing regulations and evolving requirements in environmental and occupational safety? For example, is there regular evaluation and investment in

# new technologies or training for staff to ensure they stay up-to-date with the latest developments?

Ton: One clear initiative taken by AWL Hazmat Logistics, due to the absence of definitive legislation (PGS-37-2) at the time of application, is the development of tailor-made solutions to obtain the permit for lithium-ion products. This was only possible through gathering knowledge, participating in meetings with both authorities and external storage holders, developing new technologies, and providing training. With this proactive approach, AWL Hazmat Logistics is ahead of the yet-to-be-developed legislation and even contributes to its development.

significant milestone in Euro-Rijn Group's journey towards sustainable shipping.

## **Trees for Miles**

Recently, Independent Transport Logistics (ITL) announced its project Trees for Miles. Together with StartUp4Kids, ITL is planting five fruit trees in Botswana for every 100.000 kilometres driven with ITL. Before any kilometre driven, ITL kicked of their project by planting 50 fruit trees, providing shade for 500 children and feed 5.000 people in Botswana. The plan is to plant hundreds of trees throughout 2024.

#### **Carbon Border Adjustment Mechanism**

The EU's Carbon Border Adjustment Mechanism (CBAM) is a landmark tool to put a fair price on the carbon emitted during the production of carbon intensive goods that are entering the EU, and to encourage cleaner industrial production in non-EU countries. The CBAM obligation is highly dependent on the type of 'product'. During the first phase, CBAM will focus on goods most at risk of carbon leakage such as:

- Cement
- Iron and Steel
- Aluminium
- Fertilisers
- Electricity

The following Ferro Alloys, for now, are not subject to CBAM:

- Ferro Silicon
- Ferro Silicon Manganese
- Ferro Silicon Chrome
- Ferro Silicon Magnesium
- Ferro Molybdenum
- Ferro Vanadium
- Ferro Titanium

However other Ferro Alloys such as Ferro Chrome and Ferro Manganese are indeed subject to CBAM. The declaration regarding CBAM would be dependent on location, within or outside the European Community. If the importer of the goods is located within the European Community, you are obliged to make the declaration yourself, we cannot do this. If the importer is located outside the European Community, the EC requires that the Indirect Representative (IDR), Customs Broker, organises the CBAM declaration.




